## REBATE RULES

- Eligible furnaces and boilers are smaller than 225,000 BTUH. Larger equipment is eligible for custom commercial rebates (see website).
- Equipment must be new. For conversion rebates, please call GMG or visit our website.
- Equipment must be installed by a contractor with all necessary licenses.
- Equipment must be installed in a home or business in Minnesota served by Greater Minnesota Gas, Inc.
- Renters must have landlord/owner approval.
- **Paid invoice including the brand, complete model number and serial number must be included with this application.**
- Only one rebate per item installed.
- It is the responsibility of the installation contractor and the customer to ensure that the installed equipment qualifies for the rebate. GMG confirms efficiency rating at [www.ahridirectory.org](http://www.ahridirectory.org). If the equipment does not meet the requirements, no rebate will be issued.
- Rebate funds are limited and will be paid on a first-come, first-served basis.
- Equipment installed under free warranty replacement does not qualify for the rebate.
- Greater Minnesota Gas, Inc. is not responsible if the dealer does not provide accurate information about the amount of rebate or equipment eligibility.
