MINNESOTA COLD WEATHER RULE Trouble paying your bill? Let us help you.

What is the Cold Weather Rule?

The State of Minnesota created the Cold Weather Rule (CWR) to protect residential customers from having their natural gas service disconnected from October 1st to April 30th of each year.

What Do You Need to Do to Prevent Disconnection?

To be protected from having your service shut off, natural gas must be your primary source of heat and you will need to call us today to set up a CWR Payment Plan. Your monthly payment will be determined based on your *household income.

If you are unable to agree with GMG on a CWR Payment Plan, you have the right to appeal to the Minnesota Public Utilities Commission (PUC) within ten days. During this appeal process your service will not be disconnected and the PUC will assist with a payment plan.

What If I Can't Make My Payment?

If you are unable to keep your payment plan, you must immediately contact us. If you do not make your payments, GMG can shut-off your service and is not required to offer any additional arrangements.



How Can I Get Reconnected?

Once you have a CWR Payment Plan in place, your heat will be reconnected and as long as you continue to make your payments, you will be protected from shut-off until April 30th.

Third Party Designation Form

If you have a hard time understanding or reading your GMG utility bills or notices, you can delegate a third party to receive copies on your behalf so that you are assured you won't miss any important information or dates. Your delegated party is not responsible for payment of your bills.

SOME SIMPLE WAYS TO HELP save energy during cold winter months:

- Replace Air and Furnace Filters
- Seal Air Leaks around windows and doors with caulk and weatherstripping.
- Install a Programmable thermostat and lower it by 10-15 degrees when you're away from home or during the night.
- Lower the Thermostat to 68 degrees or less and invest in some cozy throw blankets.
- Reverse the direction of ceiling fan blades pushing warm air down throughout the room.
- Open those shades and curtains and let in the heat from the sun during the day and close them at night to keep the heat in.
- Lower the water heater thermostat to 120 degrees and insulate the tank.
- Install low-flow fixtures in your bathroom and kitchen.
- Run the dishwasher and clothes washer on the shortest cycle.
- Use cold water to do the laundry.
- Limit showers to 10 minutes or less.
