**AMENDED PUBLIC HEARING  
SCHEDULING ORDER**

This matter is pending before Administrative Law Judge Jessica A. Palmer-Denig.

A public hearing in this case is scheduled to be held on March 19, 2025, in a hybrid format by WebEx and in person at the Buckham Memorial Public Library in Faribault, Minnesota.
