ORDER DENYING REQUEST FOR RECONSIDERATION

**PROCEDURAL HISTORY**

On November 26, 2025, the Commission issued its Findings of Fact, Conclusions, and Order (November 2025 Order) on Greater Minnesota Gas, Inc.’s application for authority to increase rates for natural gas utility service in Minnesota.

On December 16, 2025, Greater Minnesota Gas, Inc. filed its Petition for Rehearing, Reconsideration, and Clarification.

On December 29, 2025, the Office of the Attorney General – Residential Utilities Division and the Department of Commerce filed answers to the petition.

On February 12, 2026, this matter came before the Commission.

**FINDINGS AND CONCLUSIONS**

The Commission has reviewed the entire record and the arguments of the parties. Based upon this review, the Commission finds that the request does not raise new issues, does not point to new and relevant evidence, does not expose errors or ambiguities in the November 2025 Order, and does not otherwise persuade the Commission that it should rethink the decisions set forth in that order. The Commission concludes that those decisions are consistent with the facts, the law, and the public interest, and will therefore deny the request for reconsideration.

**ORDER**

1. The Commission denies Greater Minnesota Gas, Inc.'s request for reconsideration.
2. This order shall become effective immediately.
